Good Morning Dana,

Thank you for taking a few minutes out of your day to speak with me.

I am actually looking into getting a puppy from a breeder, not a rescue. I will be getting a newfoundland puppy. When I receive the puppy, he will be 8 weeks old and according to VA state laws and by veterinary standards a dog or cat can not receive the rabies vaccine until it is 12-16 weeks old (Which will be around the end of September.). Within 48 hours of receiving the puppy, he will have seen by a veterinary and will have start the vaccination process. I will be happy to provide the paper work.

I understand the importance of providing the Alexandria Registration number and the proof of rabies vaccination but I will not be able to provide this information until after I get the puppy, which is why I put TBD on the application. I proactively submitted the application to receive the approval before I get the second dog. The last thing I want is get the second dog, provide the rabies vaccination records and for whatever reason, not get approved. Which is why I submitted the form before I received got the second dog.
