# PARKFAIRFAX CONDOMINIUM UNIT OWNERS ASSOCIATION ADMINISTRATIVE RESOLUTION NUMBER SEVENTEEN

#### SELECTION AND PRESENTATION OF ASSOCIATION AWARDS

#### **GENERAL CONDITIONS**

- 1. The Board of Directors shall from time to time create awards as it deems necessary to recognize special services performed on behalf of The Association. Such awards shall be named in this resolution, along with the reasons for their creation and the methods to be used in selecting recipients. Except for the Parkfairfax Citizens Association Outstanding Service Award, the Board of Directors may add additional awards or delete any award from this resolution.
- 2. The Board of Directors shall select one or more individuals or one or more committees to receive an award. Names of prospective recipients may be submitted by members of the Board of Directors or General Manager.
- 3. Funding for all awards, shall be through the general operating funds.
- 4. Each award shall have a presentation certificate or plaque. The Board of Directors or Management shall approve the style and formatting of each award certificate or plaque.

# PARKFAIRFAX CITIZENS ASSOCIATION OUTSTANDING SERVICE AWARD

The Parkfairfax Citizens Association Outstanding Service Award shall be the highest award presented on behalf of the Parkfairfax Unit Owners Association.

#### **RECIPIENT**

The Award may be given to any individual or resident volunteer committee that has performed a special or outstanding service which directly affects or is done on behalf of the owners and residents of Parkfairfax.

#### **PRESENTATION**

The Award shall be presented only at the Annual Meeting of the Parkfairfax Unit Owners Association and shall consist of a plaque inscribed with "Parkfairfax Citizens Association Outstanding Service Award" and the name of the recipient. More than one individual or resident volunteer committee in any year may receive the award, however the award need not be presented in each year.

#### THE EDWARD PRESTON FOUNDERS AWARD

#### THE AWARD

Created in 1998, the Founders Award is in honor of Edward Preston, who was the first recipient. Mr. Preston exemplified continuous outstanding service by an individual performed over many years on behalf of The Association.

#### RECIPIENT

The Award may be given to any individual that has performed long term service directly affecting or on behalf of the owners and residents of Parkfairfax. The recipient must be an owner or resident of Parkfairfax for at least ten years and have performed services for The Association throughout that time.

#### **PRESENTATION**

The Award shall be presented only at the Annual Meeting of the Parkfairfax Unit Owners Association and shall consist of a plaque inscribed with "The Edward Preston Founders Award" and the name of the recipient. More than one individual in any year may receive the award, however the award need not be presented in each year.

#### **VOLUNTEER OF THE YEAR AWARD**

#### THE AWARD

Created in 1980 the Volunteer of the Year Award has traditionally been presented annually.

#### **RECIPIENT**

The Award may be given to any individual or resident volunteer committee that has performed a single or long term service directly affecting or on behalf of the owners and residents of Parkfairfax. The recipient must be an owner or resident of Parkfairfax.

#### **PRESENTATION**

The Award shall be presented yearly only at the Annual Meeting of the Parkfairfax Unit Owners Association and shall consist of a framed certificate inscribed with "Volunteer of the Year Award" and the name of the recipient. More than one individual or resident volunteer committee in any year may receive the award.

#### **SPECIAL AWARDS**

The Board of Directors may approve the presentation of a Special Award at any time and for any single or long term service performed on behalf of The Association or for any other reason. A Special Award may be given to any individual or resident volunteer committee at any time.

#### PARKFAIRFAX CITIZENS ASSOCIATION OUTSTANDING SERVICE AWARD

The Parkfairfax Citizens Association represented the interests of residents of Parkfairfax from its inception in 1967 through 1979. The Citizens Association was funded strictly by individual donations received from Parkfairfax residents. When Parkfairfax became a condominium in July 1979, the Citizens Association ceased activity and turned over funds remaining in its account with the understanding and the guarantee that such funds remaining would be used strictly to finance a special award. This By agreement, the award is was to be given from time to time to a person who has d performed a special or outstanding service directly affecting or on behalf of the owners and residents of Parkfairfax. By agreement the funds were to be kept in a separate account and not used to finance any program other than the special award. The original resolution setting forth the agreement on use of funds and the process of selection for the special award was adopted in 1983. Since, its inception four individuals have received this special award as of January 1999.

Recognizing the resolution on this award was outdated and the selection methods put forth in the original resolution are impossible to perform given changes to the organization and structure of the Association, the Board of Directors approves the following revisions as of January 1999.

#### THE AWARD

The Parkfairfax Citizens Association Outstanding Service Award shall be the <u>highestpremier</u> award presented on behalf of the Parkfairfax Unit Owners Association.

#### RECIPIENT

The <u>recipient does not</u> have to be a <u>resident or owner of Parkfairfax</u>.

The Award shall be presented only at the Annual Meeting of the Parkfairfax Unit Owners Association and shall consist of a plaque inscribed with "Parkfairfax Citizens Association Outstanding Service Award" and the name of the recipient. More than one <u>individual person or resident volunteer committee</u> in any year may receive the award, however the award need not be presented in each year.

The Award may be given to any <u>individual person who that</u> has performed long term service directly affecting or on behalf of the owners and residents of Parkfairfax.
