Income Tax Explanation

The payment is for the **capital gains taxes regarding the two units sold during the past Fiscal Year**. Barkan mistakenly recorded the payment under this fiscal year's **income taxes** general ledger, instead of coding it against the income tax payable account set up in last year's audit, as instructed by our auditor.

Barkan has been instructed to correct this mistake, which will result in the removal of \$ 189,000 from the income taxes general ledger and will be reflected only on the balance sheet against income tax payables.

Please let me know if you have further questions in advance, so I have time to research answers with Barkan and our auditor.

Income taxes are paid by Barkan quarterly, as instructed by our certified public accountants (CPAs). These are estimated payments that are reconciled at the end of the year's financial audit, when the association may receive reimbursement. At other times, additional payments to the IRS are required.

In the ledger below, dated from the start of the fiscal year to date, we can see the estimated quarterly payments of \$ 54,000. However, there is a one-time unusual expense of \$189,321.63 for a "Tax Extension Payment 5/31/24."

As explained by our auditor, every year, Goldklang notifies Barkan's VP, Michael Feltenberger directly, with instructions to have Barkan pay for our taxes or make payment extensions. The Parkfairfax office is not involved in this process, Barkan is the entity in charge of paying Parkfairfax taxes or extensions.

Barkan was notified in September by Goldklang, and our office received the same notification at the same time. Barkan should have made the payment extension as they have every year-only this time it went unpaid until February, when they received a notification from the IRS. They issued the payment the same day (note that all IRS notifications are sent to Barkan's office as the registered financial management company, not Parkfairfax).

Even then, Michael could have reached out to the IRS to dispute the late charges and penalties, instead of paying the full amount.

I suggest we seek reimbursement from Barkan for the additional interest and late penalties, totaling nearly \$ 5,000.
